## 編 製 說 明

一、編製者：本貿易統計係由海關總稅務司署統計處根據臺灣區各海關及其分支關所建之進出口報單檔集中編製。

### 二、貨品分類：

(一) 本刊第五表所列商品係依照七十五年二月修訂公佈之「中華民國海關進口稅則」(以關稅合作理事會稅則分類為藍本)辦理；此外增設四個稅則號別，專供下列各種特殊物品歸屬之用。

9817—0000 無法按實物分類之郵包(零星應稅物品)。

9818—0000 無法按實物分類之旅客攜帶自用行李(零星應稅物品)。

9819—0000 無法按實物分類之緝獲私貨(匿報之沒收貨物，仍按照類別列入統計)。

9820—0000 無法按實物分類之特殊處理之物品。

(二) 本刊第六表所列商品係依照國際貿易標準分類辦理。

### 三、統計範圍：本貿易統計以進出國境之貨物為限，下列各項貨物不包括在內：

(一) 國內課稅區、加工出口區及保稅工廠間相互進出之貨物。

(二) 外國駐華大使館、領事館等免稅物品。

(三) 旅客攜帶免稅自用物品(入境旅客攜帶行李如依照關稅法應納進口稅者，仍按照類別列入統計，但數量零星之應稅物品歸入稅則號別 9818—0000號)。

(四) 存入保稅關棧之貨物。

(五) 出保稅關棧運往外洋之貨物。

(六) 郵包寄遞出口之零星物品(以郵包出口之一般貨物，仍按照其類別列入統計)。

(七) 郵包寄遞進口之免稅零星物品(以郵包進口之應稅物品仍按照其類別列入統計，但數量零星之應稅物品歸入稅則號別 9817—0000號)。

(八) 奉政府令准免稅之慈善機關物品。

(九) 金、銀、紙幣、有價證券等(金、銀另設四個統計表——統計表九至十二——但其數字並不列入貨物統計表內)。

#### 四、編製方法：

- (一) 出口貨物確已裝船(飛機)離港後，始認為業經出口而列入統計。
- (二) 進口貨物須俟海關一切手續辦理完竣經關放行後始予列入統計，並不於其抵達或存入聯鎖倉庫即予列入。
- (三) 存入保稅關棧之貨物，須俟其提出關棧報運進口後始予列入。

#### 五、價值：

- (一) 本刊所列進出口貨物價值，出口貨係離岸價格，進口貨係起岸價格。
- (二) 單位均為新臺幣。
- (三) 除第一表之進出口貨物分列其總值及淨值外，各圖及其餘各表所列之價值均為淨值。

#### 六、運銷國別及原產國別：

- (一) 出口國貨係以出口商所申報之運銷地分列，其運銷地有數處得隨時變更者，則以首列之運銷地為準。
- (二) 進口洋貨係按原產國別分列，此係根據進口商所申報以及有關文件所證明者為準。

七、詳細分析表：關於進出口貨物數量與淨值，本刊第五表除按貨物之稅則號別詳列外，並逐項按運銷或來源地詳予分析。

八、減號：統計表內所列數字前有減號(一)者，係表示本(七十五)年度復出口多於進口之數，或復進口多於出口之數。

九、未列名：本刊所用「n. e. s.」字樣係「未列名」之義。

十、政府或學術機構如需用國際貿易標準分類(S.I.T.C.)四位數地區別之統計資料，可洽海關總稅務司署統計處，提供電子計算機印製之資料。

附註：依照「中華民國進出口貨品分類」編製之進出口貨物統計表，本(75)年度資料已刊載於本年十二月份進出口貿易統計月報內，本刊不再刊載，以免重複。

## INTRODUCTORY NOTES

1. **COMPILER:** All statistical information in regard to China's trade as controlled by the Customs is compiled by the Statistical Department, Inspectorate General of Customs from the application files for Exports, Imports, etc., from the various Customs districts in Taiwan.
2. **CLASSIFICATION:**
  - (1) Table 5: Merchandise are classified according to the "Customs Import Tariff of the Republic of China" as promulgated in Feb. 1986 (based on the Customs Cooperation Council Nomenclature). In addition, four extra tariff numbers are provided for the classification of special goods, viz:-
    - 9817-0000 Postal parcels (if dutiable) not classified according to kind;
    - 9818-0000 Sundry goods (if dutiable) carried in passengers' baggage;
    - 9819-0000 Seizures, not classified according to kind (goods undeclared and confiscated are still classified according to kind);
    - 9820-0000 Special goods not subject to Customs examination.
  - (2) Table 6: Merchandise are classified according to Standard International Trade Classification.
3. **COVERAGE:** The statistics cover only goods exported to and imported from foreign countries, but do not cover:-
  - (1) Goods moved between the Domestic Tax Area, Export Processing Zones and Bonded Factories;
  - (2) Commodities passed duty free for embassies, legations, consulates and the like;
  - (3) Personal effects of passengers for their own private use and passed duty free (goods brought in by incoming passengers are classified under their appropriate tariff numbers if subject to payment of duty according to the Customs Law, and those of sundry nature come under tariff No. 9818-0000);
  - (4) Merchandise entered into Bonded Godown;
  - (5) Shipments abroad *ex* Bonded Godown;
  - (6) Sundry goods exported by parcel post (merchandise exported by parcel post are classified according to their appropriate statistical classification);
  - (7) Sundry goods imported duty free by parcel post (merchandise imported by parcel post are credited to the trade tables according to their statistical classifications if subject to duty, but if the contents thereof were of sundry nature, they are classified under tariff No. 9817-0000);
  - (8) Supplies imported by charitable organizations and passed duty free by special government authorities;

(9) Bullion, paper currency, securities, etc. (special tables-table Nos. 9 to 12 are, however, given for exports and imports of bullion, though they are excluded from the totals in the trade tables).

#### 4. METHOD OF COMPILING:

- (1) Exports are not considered exported until the carrying vessel (or aircraft) leaves the port.
- (2) Imports are recorded in the statistics only upon completion of all Customs formalities, but not on immediate arrival in the country, nor upon entry into Customs Joint Locked Godown.
- (3) Merchandise entered into Bonded Godown is not recorded in the statistics until withdrawn for import.

#### 5. VALUE:

- (1) Values in this issue are F. O. B. for exports and C. I. F. for imports.
- (2) The unit is in New Taiwan Dollars.
- (3) With the exception of table 1, in which both the gross and net values of exports and imports are given, values in all charts and all other tables are net.

#### 6. COUNTRIES OF DESTINATION AND ORIGIN:

- (1) Exports are credited to the country of declared destination; "optional" cargo, to the country first indicated.
- (2) Imports are classified according to the place or country declared by the importer and verified with relative documents.

7. ANALYSES IN DETAIL: For the purpose of showing the direction of trade for all items of exports and imports according to the statistical headings, ANALYSES OF EXPORTS AND IMPORTS giving details of countries of destination or origin are presented in table 5.

8. MINUS SIGN: Where figures are preceded by a minus (—) sign, they represent an EXCESS of re-exports over imports, or an EXCESS of re-imports over exports, as the case may be, during the year 1986.

9. N. E. S.: The term n.e.s. stands for "not elsewhere specified or included."

10. In case the governmental or academic agents are in need of regional trade statistics under classification of SITC four digits, they may ask the Statistical Department, Inspectorate General of Customs to offer such data out of computer.

Note: To avoid repetition, the data of exports and imports for 1986 arranged in accordance with the Classification of Import and Export Commodities of the Republic of China (C.C.C.) are not included in this issue. However, they were given in the December issue of the Monthly Statistics of Trade, 1986.

## Rate of Foreign Exchange

(甲) 出 口 :

統計表上所列各項出口貨物價值係離岸價格，其外幣按政府或政府授權之銀行公開掛牌之買入匯率折合新臺幣。

(A) Exports:

Export values given in the accompanying statistical tables are based on the F.O.B. values. They are converted into New Taiwan Dollars from the foreign currencies with the buying rates as quoted by the Government or Government Authorized Banks.

(乙) 進 口 :

各項進口貨物價值係起岸價格，其外幣按賣出匯率折合新臺幣。

(B) Imports:

Import values are C.I.F. values. They are converted into New Taiwan Dollars from the foreign currencies with the selling rates.

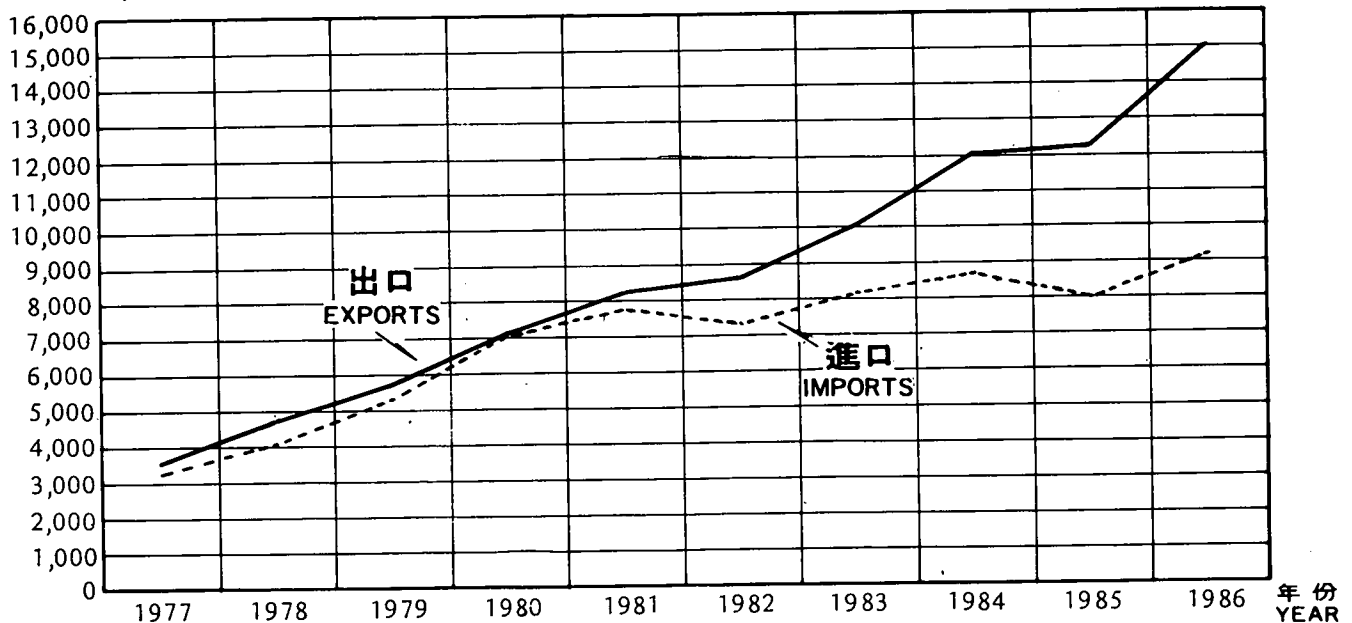
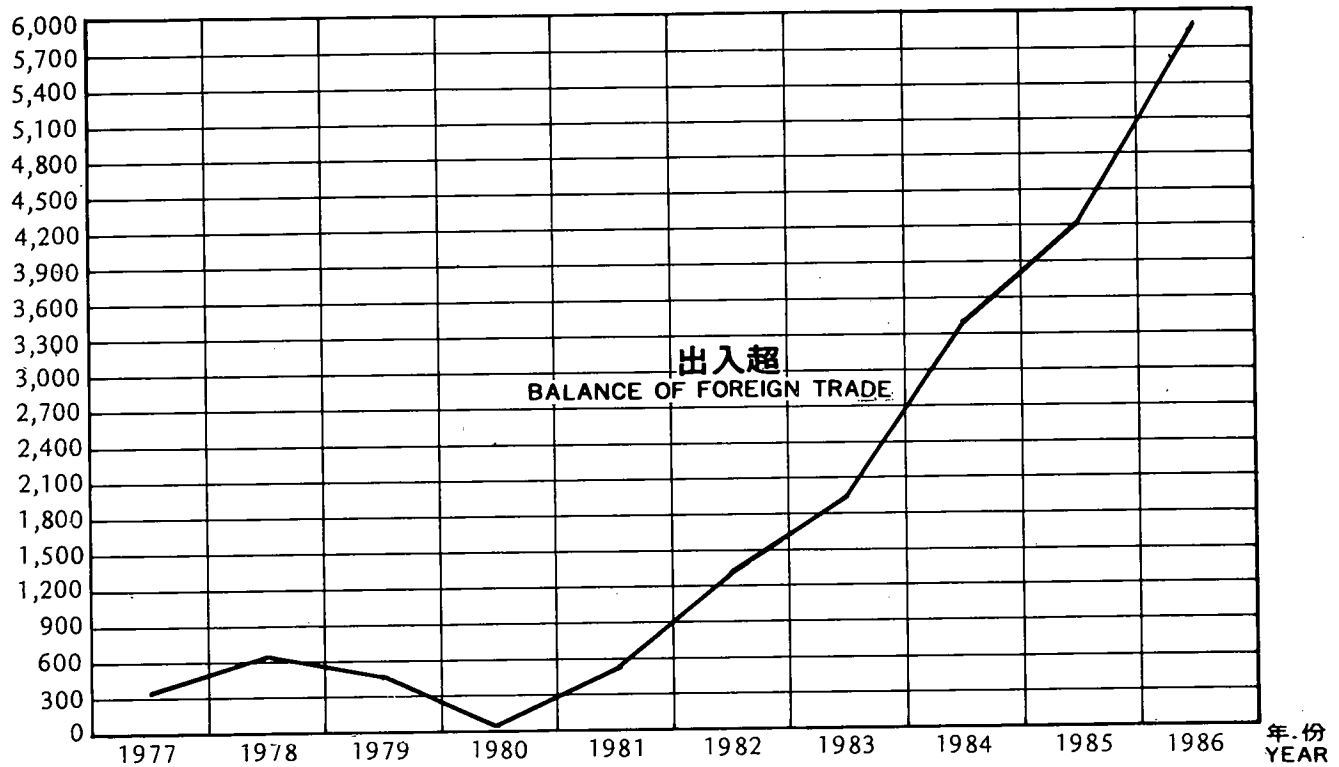

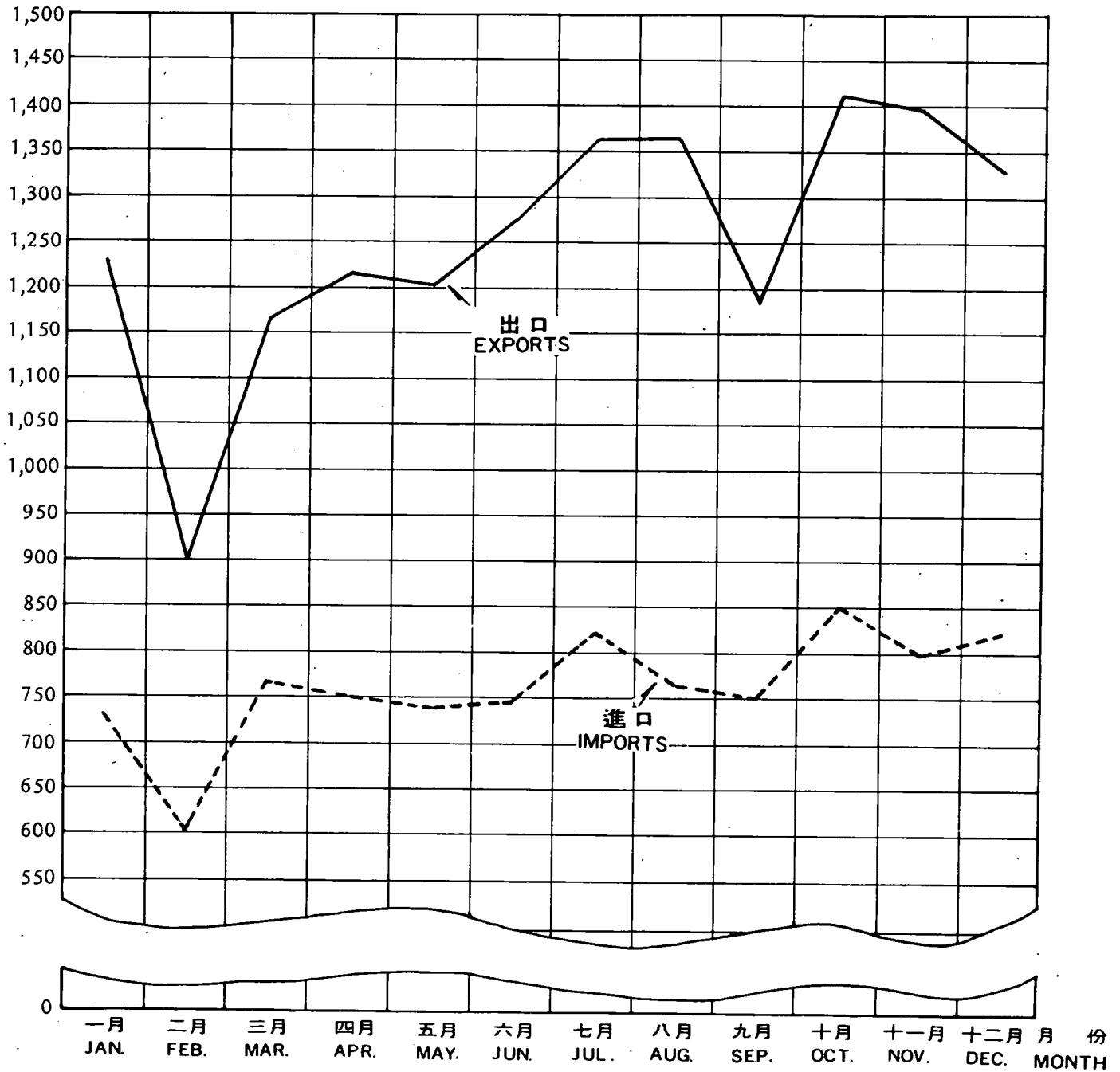

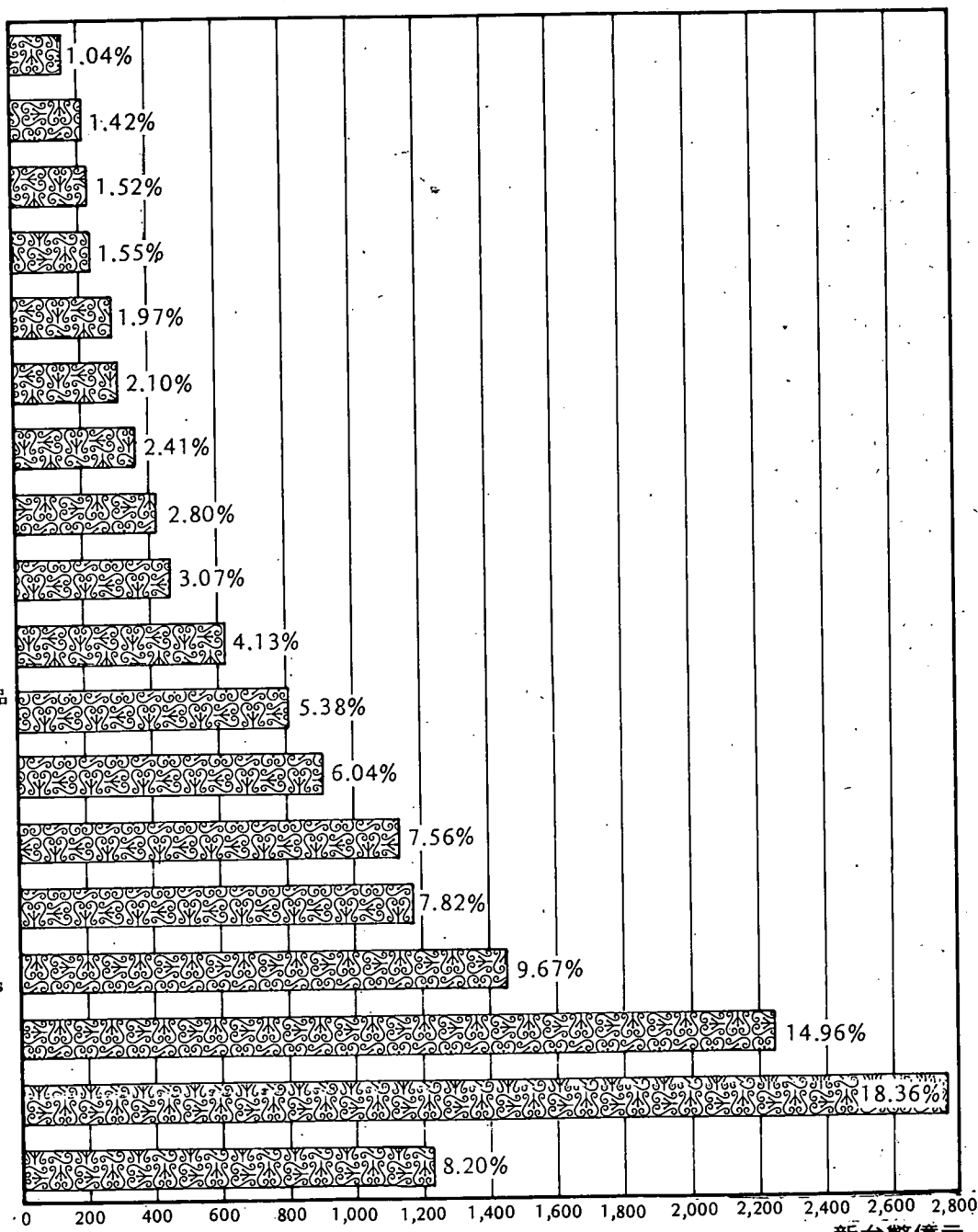

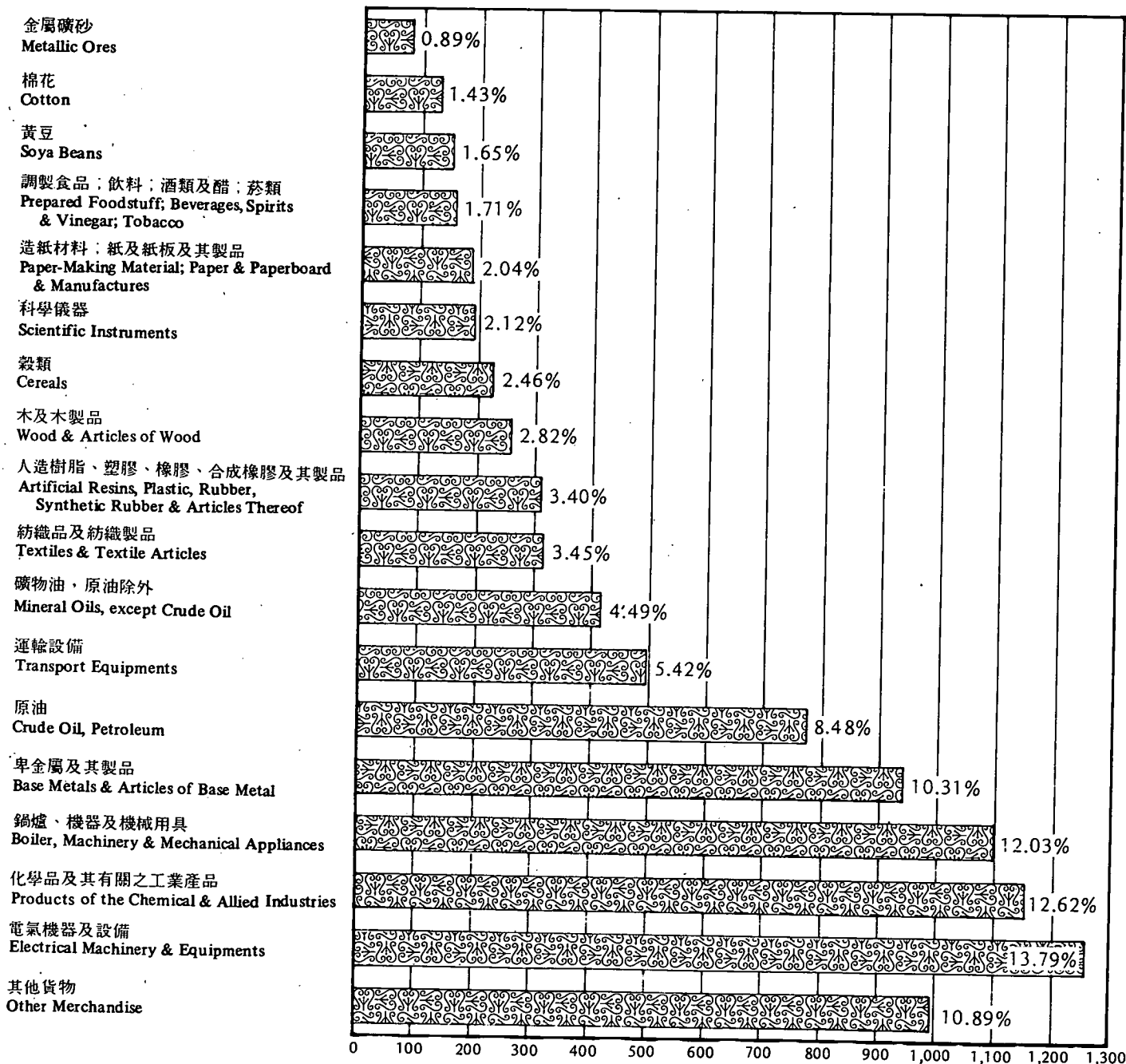

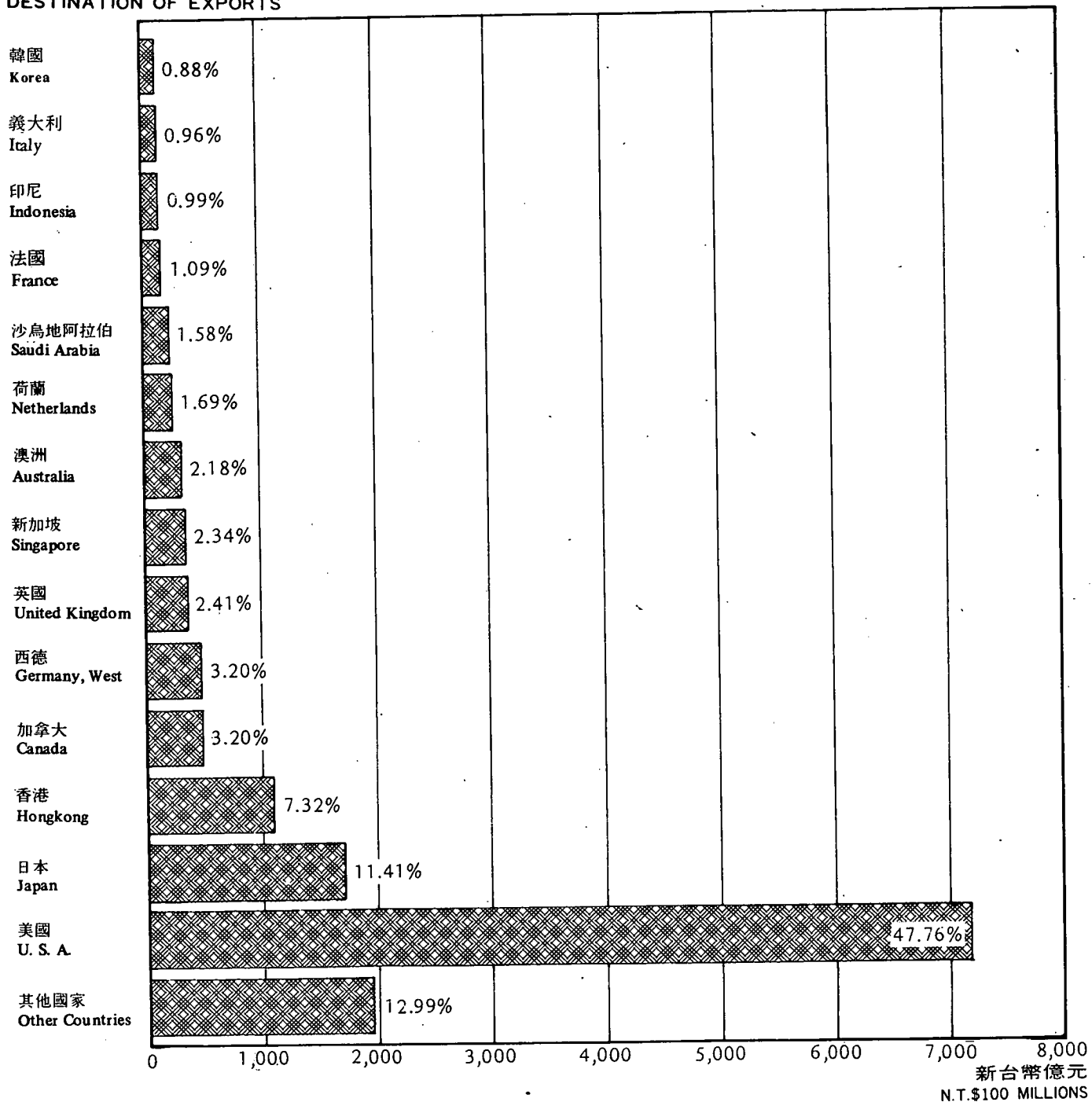

DESTINATION OF EXPORTS

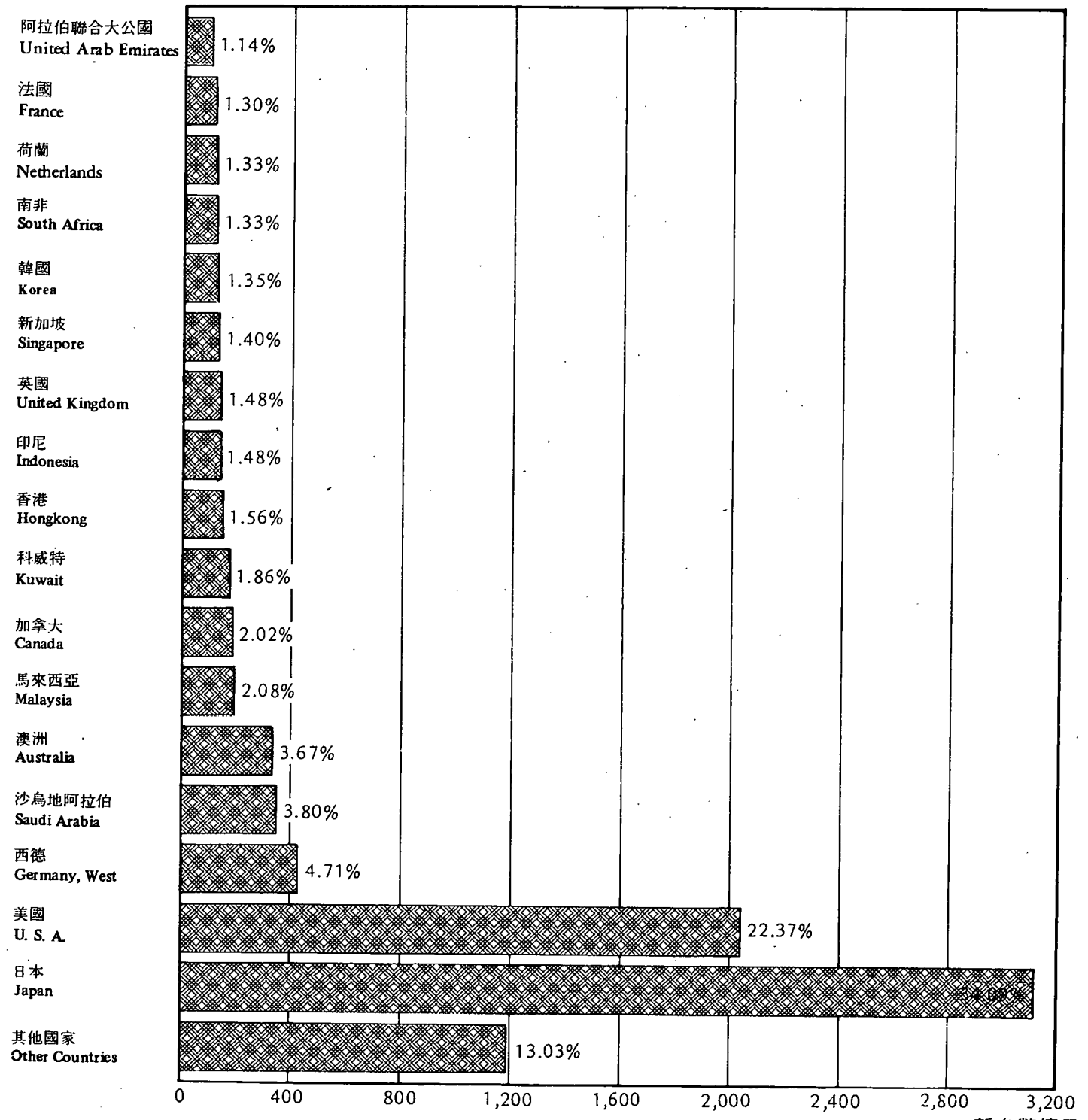


自主要貿易國家進口貨物價值比率圖

PROVENANCE OF IMPORTS

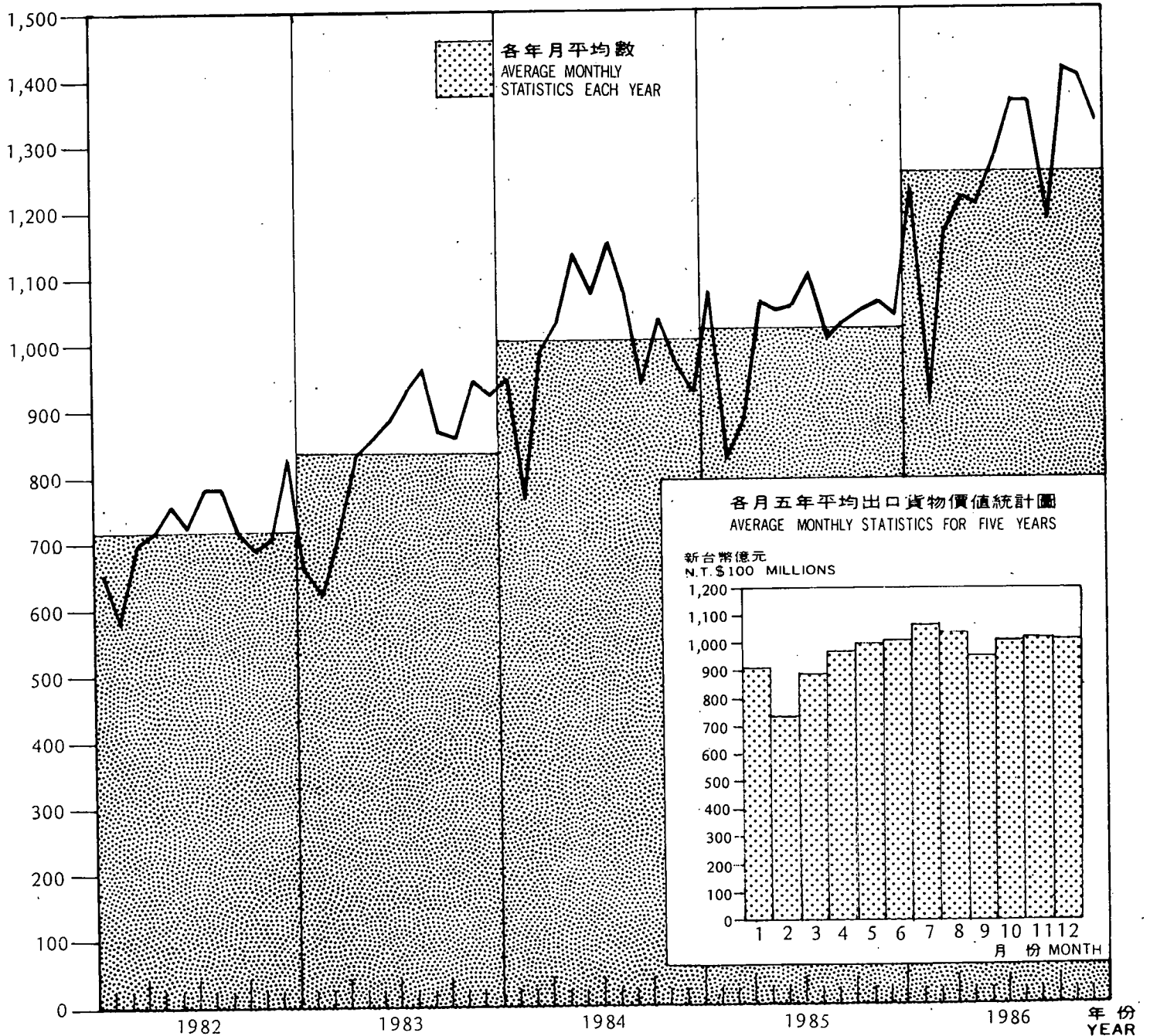
